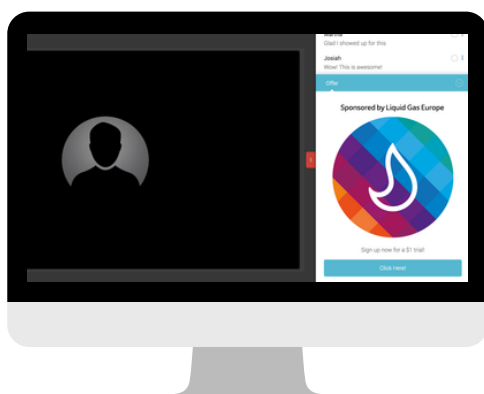

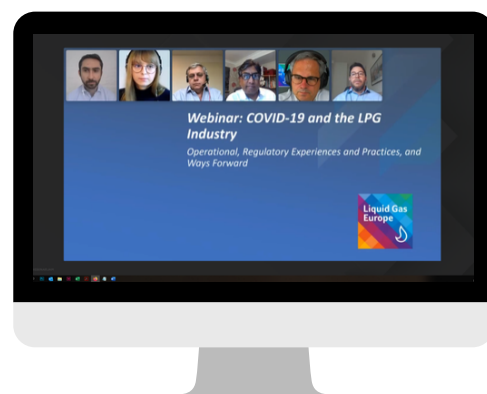
LPG Forward
